

Terms and Conditions

Personal Information

IRIS Management Services Pvt Ltd ("IMSPL") is the owner of the brand **MyFamilyMart** and the mobile app My Family Mart ("The App"). IMSPL respects your privacy. This Privacy Policy provides succinctly the manner your data is collected and used by IMSPL on the App. As a visitor to the App/ Customer you are advised to please read the Privacy Policy carefully. By accessing the services provided by the App you agree to the collection and use of your data by IMSPL in the manner provided in this Privacy Policy.

Services overview

As part of the registration process on the App, IMSPL may collect the following personally identifiable information about you: Name including first and last name, alternate email address, mobile phone number and contact details, Postal code, Demographic profile (like your age, gender, occupation, education, address etc.) and information about the pages on the App you visit/access, the links you click on the App, the number of times you access the page and any such browsing information.

Eligibility

Services of the App would be available to only select geographies in India. Persons who are "incompetent to contract" within the meaning of the Indian Contract Act, 1872 including un-discharged insolvents etc. are not eligible to use the App. If you are a minor i.e. under the age of 18 years but at least 13 years of age you may use the App only under the supervision of a parent or legal guardian who agrees to be bound by these Terms of Use. Pricing

All the products listed on the App will be sold at MRP unless otherwise specified. The prices mentioned at the time of ordering will be the prices charged on the date of the delivery. Although prices of most of the products do not fluctuate on a daily basis but some of the commodities and fresh food prices do change on a daily basis. In case the prices are higher or lower on the date of delivery not additional charges will be collected or refunded as the case may be at the time of the delivery of the order.

You Agree and Confirm

- 1. That in the event that a non-delivery occurs on account of a mistake by you (i.e. wrong name or address or any other wrong information) any extra cost incurred by IMSPL for redelivery shall be claimed from you.
